- For this year's AGM, the alliance will have a speaker from the DFO and also Adam Maclean, who will speak during the first portion of the meeting.

d) Rec Fisheries Meeting: trapping and other items

- There is a group within the province who are trying to have an outright ban on trapping They have a presence at the Charlottetown Farmers Market online, and they're being backed by the former leader of the Green party who is going to present a petition to the legislature this spring with the efforts to ban trapping altogether.
